

**RESOLUTION OF THE BOARD OF EDUCATION
OF
DOUGLAS COUNTY SCHOOL DISTRICT, RE-1**

Plan for Distribution of Additional Mill Levy Revenue

WHEREAS, last year, the Colorado General Assembly enacted House Bill 17-1375, codified in relevant part at C.R.S. § 22-32-108.5, which provides that, for the 2019-20 budget year and for each budget year thereafter, a local board of education of a participating school district shall either (i) distribute to each charter school of the district 95% of its district per pupil mill levy share multiplied by the number of students enrolled in each charter school, or (ii) implement a plan for equitably distributing its additional mill levy revenue to support all students, regardless of what type of school in which they are enrolled; and

WHEREAS, pursuant to C.R.S. § 22-32-108.5(4)(a), a local board that chooses to implement a plan for the 2019-20 budget year must adopt the plan by July 1, 2018; and

WHEREAS, Douglas County School District (the “District”) authorizes one or more charter schools and, therefore, is a participating school district as defined in C.R.S. § 22-32-108.5(2)(f); and

WHEREAS, pursuant to a resolution adopted by the District Board of Education (the “Board”) on March 2, 2010, the District currently distributes 100% of its district per pupil mill levy share to District-authorized charters schools (except multi-district online charter schools) in the manner required by C.R.S. § 22-32-108.5(3); and

WHEREAS, in accordance with C.R.S. § 22-32-108.5(4)(a), the Board desires to adopt and implement a plan that maintains its current level of mill levy distribution to District-authorized charter schools, and to preserve its right to periodically review and update the plan in accordance with C.R.S. § 22-32-108.5(4)(e).


NOW, THEREFORE, BE IT RESOLVED that the Board of Education of the Douglas County School District, Re.1:

THAT, beginning in the 2018-19 budget year and in each budget year thereafter, the Board shall distribute to each charter school (except multi-district online charter schools) of the District an amount equal to 100% of its per pupil mill levy share for the applicable budget year multiplied by the number of funded pupils enrolled in each of its charter schools for the applicable budget year; and

THAT, the Board shall periodically review the plan and update it as necessary to ensure that the additional mill levy revenue that the District collects is equitably distributed as provided in C.R.S. § 22-32-108.5(4)(a) to (4)(c) to the schools of the District to benefit all of the students enrolled in all of the schools of the District.
