

As of 3/5/21 student eligibility for COVID vaccine per the [Colorado Department of Public Health and Environment](#) is:

- Effective 3/8/21  
1.B.3 - People 16-59 with 2 or more high risk conditions: • The intent of this classification is to vaccinate Coloradans who have a high risk of severe outcomes from COVID-19. This includes Coloradans with two or more of the following: Cancer (defined as patients who are currently receiving treatment or have received treatment within the last month for cancer), chronic kidney disease, COPD, diabetes mellitus (types 1 and 2), Down syndrome, specific heart conditions (heart failure, cardiomyopathies or coronary heart disease, and severe valvular/congenital heart disease), obesity ( $BMI \geq 30\text{kg}/\text{m}^2$ ), pregnancy, sickle cell disease, solid organ transplant, individuals with disabilities who require direct care in their home, and people with disabilities that prevent them from wearing masks.
- Late March  
1.B.4 - People 16-49 with one of the high risk conditions listed on the website. It includes Coloradans with one condition listed in 1B.3 or asthma (moderate-to-severe), Cerebrovascular disease (affects blood vessels and blood supply to the brain), Cystic fibrosis, Hypertension or high blood pressure, Immunocompromised state (weakened immune system) from blood or bone marrow transplant, immune deficiencies, HIV, use of corticosteroids, or use of other immune weakening medicines, Neurologic conditions, such as dementia, Liver disease, Pulmonary fibrosis (having damaged or scarred lung tissues), Thalassemia (a type of blood disorder).

Parents may access vaccines for their eligible children from some of DCSD's vaccine providers.

- Kaiser Permanente will provide vaccine appointments for eligible youth. Parents may register their eligible children whether they are Kaiser members or non-members.
  - Kaiser Permanente members:
    - Fill out the COVID-19 Vaccine Sign-up E-visit at [kp.org/covidvaccine](http://kp.org/covidvaccine)
    - Or, complete a short questionnaire by calling 1-844-951-1932.
    - Once you sign up, you don't need to take any further action. We will hold your place in our virtual line and notify you when you are eligible and when vaccine supply is available.
  - Non-Kaiser Permanente members:
    - Go to [kp.org/covidvaccine](http://kp.org/covidvaccine)
    - Complete the non-member brief intake to request the vaccine.
- Children's Hospital will directly contact patients or parents of patients who qualify for the next phase of vaccinations to offer an opportunity to receive the vaccine. Vaccinations will be administered at our hospitals on [Anschutz Medical Campus](#) or in [Colorado Springs](#) at the Memorial North campus. To determine eligibility, Children's Colorado is examining electronic health records to identify patients with two or more high-risk medical conditions that meet CDPHE's guidelines. - Centura Health will provide vaccine appointments for eligible youth. Parents may register their eligible children on the [Centura Health website](#).
- STRIDE Community Health will be accepting eligible youth who are 18 and older on their wait list for vaccine appointments. Parents may register their eligible children on the [STRIDE website](#).
- UC Health - For those that have a My Health Connection account, they can go to [uchealth.org/myhealthconnection](http://uchealth.org/myhealthconnection), log into their account and select the “COVID-19 vaccine phase” questionnaire in order to indicate which phase of the state’s vaccine distribution plan they qualify. The questionnaire title will be highlighted green if they have not completed it. If they don’t have a My Health Connection account and would like to create one, they can go to [uchealth.org/myhealthconnection](http://uchealth.org/myhealthconnection) and select Sign up now. They will then be asked to verify the vaccine phase in which they are eligible.
